

The AO is working as Joint Sub-Registrar Gr-I, Sub-Registrar office, Ananthapuramu Urban and residing at Ananthapuramu. AO got married and is having two children.

The AO indulged in corrupt practices, extracted bribes from those who approached him for service and he enjoys bad reputation.
