It is to submit that Sri Devisetty Durga Prasad S/o Venkateswarlu, age 46 yrs, Occ: DSP, Police Training College (PTC), Ongole, Prakasam district, R/o 5-6-1 (old), 5<sup>th</sup> Lane, Brodipet, Guntur town, Guntur District is working as Deputy Superintendent of Police, Police Training College (PTC), Ongole, Prakasam District.

The Suspected Officer (Devisetty Durga Prasad) is native of Cheerla Town, Prakasam District and his father Sri Devisetty Venkateswarlu was a retired court employee (lower grade). The S.O has two elder brothers namely D.Srinivasa Rao, Excise SI and D.Maruthi Vidyasagar were residing at Chirala town. S.O got married to Smt Emani Naga Durga Rajasri D/o Sri Emani Saibaba. S.Os father-in-law was a retired Physics lecturer, Government Women's college, Guntur, got superannuation in the year 2000 and was demised about in the year 2014. S.O. has only one daughter namely Sai Durga Pravallika, presently pursuing her studies in B.Tech (Computer Science) in KL University, Guntur. SO's brother-in-law Sri Emani Naga Durga Srinivas is an IT Engineer has been staying at Hyderabad. Now mother-in-law of SO is residing with the family of SO in one house.

The S.O Joined in Government Service on 19-09-1991 as Sub-Inspector of Police and was promoted as Inspector of Police in the year 2007 . While on duty, he was suspended when he was working as CI of Pattabhipuram Police Station, Guntur town on 18.11.2013 for involving in a civil dispute vide in Cr.No.199/2013 U/S 448,427,379,506 r/w 34 IPC. After revoked from suspension, subsequently he got promoted as DSP in the year 2014. He worked in various places in Guntur District since date of entry into service i.e., 1991 to 2014. Presently he is working as Dy. Supdt. of Police, Police Training College (PTC), Ongole, Prakasam District.

During his service i.e., since joining in the department till date he had acquired assets by dubious means and illegal practices in shape of Flats, houses and open plots all worth of Rs. 1,46,54,600/- which are held in his name and in the names of his wife and his mother-in-law and benamies.

The properties pertaining to the benamis i.e. E.Usha Rani (mother-in-law), T.Subbarao and S.Ramesh purchased on their personal were excluded as per their income sources and all properties held in the name of SOs brother-in-law E.Naga Durga Srinivas are not taken in to source basing on income sources of his family members and himself. Further in detail probe about financial sources and an income particulars of benamis is necessary to verify through investigation.

His income from the different sources during the said period approximately arrived at Rs.70,00,000/- and his expenditure during the said period under different heads was approximately arrived at Rs. 26,00,000/-.

As seen from the income and expenditure, there is a likely savings of Rs. 44,00,000/- (Income – Expenditure). As against the likely savings of Rs. 44,00,000/-, Sri Devisetty Durga Prasad (S.O) is in possession of assets worth Rs. 1,46,54,600/-.
