

It is submitted that, basing on the Telugu typed complaint of Sri Kuraku Pedda Venkataiah, 60 Years, S/o K.P.Venkataiah, Occ: Retired Office Subordinate, Irrigation Circle, Kadapa, R/o Thuvvapalli Village, Mydukur Mandal, YSR District, Kadapa, a case in Cr.No.2/RCT-KDP/2021 U/s 7 of PC (Amendment) Act, 2018 was registered in ACB, Kadapa on 13-3-2020 at 8.30 AM against the Accused Officer Sri Shaik Abdul Jabbar, 50 Years (DOB: 05-06-1970), S/o Nayab Rasool, Senior Auditor, O/o the District Audit Officer, Kadapa, R/o D.No.56/586-5, Near Saibaba School, Akkayapalli, Kadapa Town, YSR Kadapa District and obtained necessary permission from the competent authority to lay trap against the Accused Officer. The Accused Officer was trapped on 1-3-2021 at 11.45 AM in the O/o the District Audit Officer, Kadapa, when the AO demanded and accepted bribe of Rs.5,000/- as illegal gratification other than legal remuneration from the complainant Sri Kuraku Pedda Venkataiah for processing of the pension payment order of the complainant and to forward the same to the District Treasury.

The copies of FIR, pre-trap proceedings (Mediators Report-I), post-trap proceedings (Mediators Report-II) and rough sketch of the scene of offence are herewith submitted for favour of kind perusal.
