

It is submitted that, basing on the Telugu typed complaint of Sri Jarugu Harinadha Reddy, S/o J. Muni Reddy, R/o D.No. 27/53, Chenchureddygaripalli, H/o Madhavaram (V), Rayachoty Mandal, YSR District, Kadapa, a case in Cr.No.04/RCT-KDP/2021, U/s 7 (a) of PC (Amendment) Act, 2018 was registered in ACB, Kadapa on 01.07.2021 at 11.00 AM against the Accused Officer Sri Akula Mallikarjunappa, 58 Years S/o Nagabhushanappa, Executive Engineer, FAC Superintending Engineer, O/o the SE, RWS&S, Kadapa, N/o Flat No. 503, Ram Nagar, Anantapuramu town and District, R/o Near Krishna Temple, Dwaraka Nagar, Kadapa Town, YSR District and obtained necessary permission from the competent authority to lay trap against the Accused Officer. The Accused Officer was trapped on 01.07.2021 at 01.40 PM in the Chamber of the AO O/o SE, RWS&S, Kadapa District, when the AO demanded and accepted bribe of Rs.6,000/- as illegal gratification other than legal remuneration from the complainant Sri Jarugu Harinadha Reddy for doing an official favour for passing the bill amount of Rs. 6,69,195/- pertaining to a civil work executed by the complainant at Jagananna Colony, Diguva Abbavaram (V), Rayachoty (M) under "Drinking Water supply scheme".

The copies of FIR, pre-trap proceedings (Mediators Report-I), post-trap proceedings (Mediators Report-II) and rough sketch of the scene of offence are herewith submitted for favour of kind perusal.
