Honoured Sir,

It is submitted that Sri Nemallapudi Prabhakar Reddy, S/o Late Chandra Reddy working as U.D.C., (Upper Divisional Clerk) APSPDCL at the O/o A.D.E., Millennium Sub-Station, Town-II Sub-Division, Rammurthy Nagar, Nellore City, SPSR Nellore District.

He is a native of Nawabpet, Nellore city, SPSR Nellore District and residing in D.No.26-14-1331-1, Ramakrishna Nagar, Vanamthopu, Kondayapalem, Nellore City, SPSR Nellore District. He is only son to his parents. His father Sri Late Chandra Reddy was died in the year 1994 and he got job on compassionate grounds. After few years, SO's mother Nemallapudi Syamalamma was also died. SO married Smt.N.Kalyani, who is only daughter of her parents Sri Sanam Vasudeva Reddy and Sugunamma resident of Mettu village, Chittamuru Mandal, SPSR Nellore District during August-1996. The AO is not inherited any ancestral property either from his parents or from his in-laws. S.O. had two daughters.

The suspected officer had joined as J.L.M.,(Junior Line Man) at Kothuru Sub-Station, Nellore city on 31.05.1998 and promoted as LDC thereafter UDC. During the check period i.e., from 31.05.1998 to 28.01.2019 the S.O had intentionally enriches disproportionate assets all worth of Rs. **69,25,935/-** which were held in his name and in the name of his wife, illicitly during the above said check period.

SO's income from the different sources during the said period approximately arrived at Rs.**50,00,000/-** and his expenditure during the said period under different heads was approximately arrived at Rs. **30,02,235/-** for the check period.


As seen from the income and expenditure, there is a likely savings of Rs. **19,97,765/-** (Income – Expenditure). Sri Nemallapudi Prabhakar Reddy (S.O) is in possession of assets worth of Rs. **89,23,700/-** against his likely savings of Rs. **19,97,765/-**. Thus, SO is in possession of assets disproportionate worth of Rs. **69,25,935/-** (Assets – likely savings) which are intentionally enriches himself (S.O) illicitly during the working period (check period) of his office by committing criminal misconduct, thereby S.O had committed an offence punishable U/s 13(1)(b) of Prevention of Corruption (Amendment) Act, 2018.

A Source report was sent to the Director General, ACB, AP, Vijayawada requesting to issue proceedings to register a case against the AO. Accordingly the Joint Director (R), Anti-Corruption Bureau, A.P., Vijayawada has accorded permission vide proceedings No.01/RCA-JD(R)/2019, dated 28-01-2019 authorizing Sri A.Srihari Rao, Inspector of Police, A.C.B., Nellore Range, Nellore to register a case against Sri Nemallapudi Prabhakar Reddy, S/o Late Chandra Reddy, Occ: U.D.C. (Upper Divisional Clerk) APSPDCL, O/o ADE, Millennium Sub-Station, Town-II Sub-Division, Rammurthy Nagar, Nellore City, SPSR Nellore District, Andhra Pradesh, U/s 13(1)(b) of Prevention of Corruption (Amendment) Act, 2018 and to investigate it.

Therefore, I registered a case in Cr. No.01/RCA-ACB-NLR/2019 U/s 13(1)(b) of Prevention of Corruption (Amendment) Act, 2018 on 04-02-2019 at 10.00 AM against Sri Nemallapudi Prabhakar Reddy, S/o Late Chandra Reddy, Occ: U.D.C. (Upper Divisional Clerk) APSPDCL, O/o ADE, Millennium Sub-Station, Town-II Sub-Division, Rammurthy Nagar, Nellore City, SPSR Nellore District, Andhra Pradesh, R/o D.No.26-14-1331-1, Ramakrishna Nagar, Vanamthopu, Kondayapalem, Nellore City, SPSR Nellore District.


