**IN THE COURT OF HON'BLE SPECIAL JUDGE FOR SPE & ACB CASES, NELLORE.**

Honoured Sir,

It is to submit that Sri Srungarapu Venkata Narendra, S/o Late Venkata Rao, Age 44 Yrs, Jr.Assistant, O/o the Commissioner, Municipal Corporation, Ongole, Prakasam District, by abusing his official position and by indulging in corrupt practices and irregularities has acquired assets disproportionate to his known sources of income.

Sri Srungarapu Venkata Narendra was born on 19-05-1973. He joined Government Service as a Junior Assistant in Municipal Department on 26.02.1994 in lieu of his father Venkata Rao who worked as a Junior Asst. in Municipal administration department and went on Compulsory Retirement on Medical Grounds. His father is no more. He did most of his service in Ongole Municipality and acquired the properties in the limits of Ongole Municipal Corporation. .

During the period of his service he acquired assets in the shape of house plots and residential buildings etc., all worth **Rs.85,34,833/-** which are held in his name and in the name of his family members.

As seen from the above, Srungarapu Venkata Narendra derived a total income of **Rs.35,00,000/-** whereas the expenditure is **Rs 33,50,000/-**. Thus there is likely savings of **Rs.1,50,000/-** i.e. Income- Expenditure. He is in possession of assets worth about **Rs.85,34,833/-**. Thus he is in possession of assets disproportionate to his known sources of income to a tune of about **Rs.83,84,833/-** (Assets – Likely savings) (i.e., 240%) for which he cannot satisfactorily account for, and there by committed an offence punishable U/s 13(2) r/w 13(1)(e) of the Prevention of Corruption Act, 1988.

Basing on the source report submitted to the Director General, ACB, AP, Vijayawada, the Additional Director & I/c Joint Director (CZ), Anti-Corruption Bureau; Vijayawada has accorded permission Vide proceedings No.7/VJA-AD(I/C-JD(CZ)/2017 DT.24-07-2017 authorizing Sri T.Prabhakar, Dy.Suptd.of Police, Anti-Corruption Bureau, Prakasam district, Ongole to register a case against Sri Srungarapu Venkata Narendra, S/o Late Venkata Rao, Age 44 Yrs, Jr.Assistant, O/o the Commissioner, Municipal Corporation, Ongole, Prakasam District, U/s 13 (2) R/w 13 (1) (e) of the Prevention of Corruption Act,1988 and to investigate the same and to submit report.

Therefore, I registered a case in Cr. No.7 /RCA-OGL/2017 U/s 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988 on 26-07-2017 at 07-00 hrs and submitted original FIR along with the original proceedings of the Additional Director & I/c Joint Director (CZ), Anti-Corruption Bureau, Vijayawada to the Hon'ble Spl Judge for SPE & ACB Cases, Nellore.
