It is to submit that Sri Pagadala.Ravi Prakash S/o Late Venkatappa, Age: 52 Yrs, Dy. Executive Engineer, PRI Division, Ongole, Prakasam District by abusing his official position and by indulging in corrupt practices and irregularities has acquired assets disproportionate to his known sources of income.

Sri Pagadala.Ravi Prakash was born on 01-06-1965. On 12-05-1992, he joined in Government Service as an Assistant Executive Engineer (AEE) in Panchayat Raj (PRI) department and later promoted as Dy.Executive Engineer(DEE). He did majority of his service in Prakasam district.

During the period of his service he acquired assets in the shape of house plots and residential buildings etc., all worth **Rs.92,92,000/-** which are held in his name and in the name of his family members.
