OCCURRENCE REPORT

Sri Tangella Hari Krishna S/o Late Suranna, age 57 years, Fame Heights Apartments, Flat No. 502, Ramnagar, Visakhapatnam District, joined as Sub-Inspector of Police, Eluru Range on 16.01.1989 and promoted to the present rank of Additional Superintendent of Police, and now he is working as Additional Superintendent of Police as Chief Vigilance Officer in APEPDCL, AP Transco, Visakhapatnam.


During his service while he is working in the department since purchase of the first asset i.e., from 2006 to till date he acquired assets by dubious means and illegal practices in the shape of houses, house sites, lands all worth of Rs. 2,03,24,740/- at Srikakulam District, East Godavari District, West Godavari District, Visakhapatnam District, Krishna District, Hyderabad and nearby places on his name and also in the names of his wife and Son.

His income from the different sources i.e. salary income and Bank loans during the above said check period i.e., from 2006 to till date is approximately estimated at Rs. 60,00,000/-, his Expenditure during the above said period under different heads were approximately arrived at Rs. 30,00,000/-.


As seen from the income and expenditure, there is a likely savings of Rs. 30,00,000/- (Income - Expenditure). As against the likely savings of Rs. 30,00,000/- Sri Tangella Hari Krishna S/o Late Suranna, Additional Superintendent of Police as Chief Vigilance Officer in APEPDCL, AP Transco, Visakhapatnam, is in possession of assets worth of Rs. 1,73,24,740/-

Thus, Sri Tangella Hari Krishna is in possession of assets which are disproportionate to the known sources of his income to a tune of Rs.1,73,24,740/- (Assets - likely savings) for which he cannot satisfactorily account for, and thereby he committed an offence punishable U/s 13(1) (b) of the Prevention of Corruption (Amendment) Act, 2018.

The Joint Director (A), Anti-Corruption Bureau, Vijayawada vide proceedings RC.No.15/RCA-JD(A)/2019 dated 16-12-2019 has accorded permission authorizing Sri B.V.S.S Ramana Murty, Deputy Superintendent of Police, ACB, Srikakulam Range. to register a case against Sri Tangella Hari Krishna S/o Late Suranna, age 57 years, Fame Heights Apartments, Flat No 502, Ramnagar, Visakhapatnam District U/s 13 (1) (b) of the Prevention of Corruption (Amendment) Act, 2018 and to investigate it.
