It is to submit that the Accused Officer Sri Koneru Sai Krishna S/o Chandra Sekhar Rao, Age 52 Yrs., Superintendent cum Auditor, Board of Intermediate Education, AP, Vijayawada, now working in O/o the Commissioner of Intermediate Education, AP, Guntur, R/o Door No.40-25-31, 2<sup>nd</sup> Floor, VK PRIDE, Patamata Lanka, Patamata, Vijayawada, joined in Government Service as Junior Assistant in the year 1993 in the office of Director, Board of Intermediate Education, AP and promoted as Senior Asst as on 1-6-2014 and now raised to the cadre of Superintendent cum Auditor and now working at O/o Commissioner, Intermediate Education, Guntur, Andhra Pradesh

The Accused Officer is native of 11<sup>th</sup> Division, Vijayawada Urban, Krishna District. S.O's father late Sri Koneru Chandrasekhar Rao is a small farmer. S.O. is the elder among his two brothers. SO's younger brother Koneru Sai Raja is residing at Hyderabad of Telangana State and he is a private employee. The S.O. got married Smt. Sowjanya, native of Gannavaram (M) of Krishna District. The father-in-law of SO late Sri Ramineni Subba Rao is a native of Dhavajigudem H/o Buddhavaram Village, Gannavaram Mandal, Krishna District. He is also a small farmer. The SO blessed with son and daughter i.e., Koneru SaiKiran, aged about 24 Yrs, and Koneru Yoshitha, aged about 19 Yrs. His son completed B.Tech. and his daughter is studying B.Tech.

The **Accused Officer** had intentionally enriches properties illicitly all worth of Rs. 1,70,47,000/- which are held in his name, his family members during check period from 01.10.2000 to 01.12.2020.

AO's income has arrived from the different sources during the said check period approximately at Rs. 1,33,29,500/- and his expenditure arrived during the said period under different heads was approximately at Rs. 55,65,484/-.

As seen from the income and expenditure, there are likely savings of Rs. 77,64,016/- (Income – Expenditure). Sri Koneru Sai Krishna (A.O) is in possession of assets worth of Rs. 1,70,47,000/- against his likely savings of Rs. 77,64,016/-. Thus, AO is in possession of assets which are disproportionate to the known sources of his income to a tune of Rs. 92,82,984/- (Assets – likely savings) which are intentionally enriches himself (AO) illicitly during the working period (check period) of his office by committing criminal mis-conduct, thereby he (AO) had committed an offence punishable U/s 13(1)(b) r/w 13 (2) of Prevention of Corruption (Amendment) Act,2018.

The Joint Director (CZ), Anti-Corruption Bureau, A.P., Vijayawada vide proceedings No. 01/JD(CZ)-ACB/2021, dt. 09-02-2021 has accorded permission authorizing Sri A.V.Siva Kumar, Inspector of Police, ACB, Vijayawada Range to register a case against Sri Koneru Sai Krishna S/o Chandra Sekhar Rao, Age 52 Yrs., Superintendent cum Auditor, Board of Intermediate Education, AP, Vijayawada, now working in O/o the Commissioner of Intermediate Education, AP, Guntur, U/s 13(1)(b) r/w 13 (2) of P.C. (Amendment) Act.2018 and to investigate it.
