## OCCURRENCE REPORT

The Accused Officer joined as Health Assistant on 29.05.1991 in the department of Municipal Administration & Urban Department and worked as such in Bheemili Municipality. He promoted as Sanitary Inspector and worked at Bheemili Municipality, Visakhapatnam district. He promoted as Food Inspector and worked as such in Vizianagaram Municipality. He promoted as Municipal Commissioner (Grade-II) in the year 2012 and worked as such in Nellimarla and Bobbili Municipalities, Vizianagaram district and recently, he was transferred to Narsipatnam Municipality of Visakhapatnam district. Presently, he is working as Commissioner, Narsipatnam Municipality since 15.02.2019.

The AO is a native of Gopinadhapuram Village, Tekkali Mandal, Srikakulam district and hails from a middle class family. His father late Hanumanthu Narasinga Rao was a retired Teacher and mother Smt. Hanumanthu Kamakshamma is a house wife. The AO has one brother Sri Hanumanthu Ramana Murthy and he is working as Dietician, in Govt. Hospital for Mental Care, Visakhapatnam.

The AO married Smt. Hanumanthu Eswareebai, D/o Kanithi Suryanarayana in the year 1995 and she is house wife. AO's father-in-law is a farmer and his mother-in-law Smt Savitri is a house wife. The AO has a brother-in-law Kanithi Chakradhar and he is a Medical Representative at Visakhapatnam. The AO blessed two sons namely Surya Pavan, did B.Tech in SRM University, Chennai and Sai Sampath, studying Intermediate (Bi.P.C) in Sri Chaitanya College, Visakhapatnam.

Basing on his bad reputation, a discreet enquiry was conducted in which it is learnt that he misused and abused his official position and amassed wealth by illegal and dubious means in the shape of movable and immovable properties in his name and in the names of his family members and his close associates during the check period from 20.12.2000 (i.e. probable date of acquiring first asset) to till date.

The AO during the check period from 20.12.2000 (i.e. probable date of acquiring first asset) to till date by his illegal and dubious means acquired house plots, flats, house building, agricultural lands, valued about **Rs. 1,35,41,500/-**. The income of AO from all legal sources during the check period is worked out to **Rs.90,00,000/-** and the expenditure incurred by him for the maintenance of his family, children education etc, during the said check period is worked out to **Rs. 39,89,900/-**.

Thus, the AO is having likely savings during the above check period to a tune of Rs. **50,10,100/-** (Income Rs. **90,00,000/-** minus expenditure Rs. **39,89,900/-**).

Therefore, the AO Sri Hanumanthu Sankara Rao S/o Narsinga Rao is in possession of assets valued **Rs.85,31,400/-** (Total assets valued **Rs.1,35,41,500/-** minus Rs. **50,10,100/-**), disproportionate to the known sources of his income.
