That the Accused Officers 1) Sri K.Hari Gopal, Revenue Inspector and 2) Sri Mahesh, Tax Collector demanded the bribe amount of Rs.1,00,000/- from the complainant Sri G.Ravi for not enhancing the property tax on the building bearing Door Nos.10-40-17/1, 10-40-17/2 and 10-40-17/3 situated at Waltair Main Road, Ramnagar, Visakhapatnam of Smt Konuganti Jyothi of Hyderabad who is sister of the complainant.

Sir,

I, Godey Ravi S/o Late Rama Krishna, residing at Door no.9-14-13/1, V.I.P.Road, C.B.M. Compound, Visakhapatnam. My sister Smt Kanuganti Jyothi W/o Kishan, residing at D.No.690, Abid Nagar Colony, Hyderabad. She owns a building in ward No.19, Waltair Mainroad, Ramnagar, Visakhapatnam and it was assessed under assessment no.1086151027 (D.No.10-40-17/1), 1086151028 (D.No.10-40-17/2) and 1086151029 (D.No.10-40-17/3). On 10-06-2019, one Hari Gopal, Revenue Inspector, G.V.M.C., Visakhapatnam called me and informed that they are taking measurements of the above said building. I sent one of my staff to the spot. After taking the measurements he obtained signatures of our staff Adinarayana on acknowledgements of the notices as if the notices were issued and handed over the acknowledgements instead of notices, Sri Adinarayana brought the same and handed over to me. On 11-06-2019 Mr. Hari Gopal called me again and asked me to send one person from my office to discuss about the property tax. Accordingly I sent my office staff Mr. Poram Adinarayana to meet Mr. Hari Gopal, Revenue Inspector at his office. Mr. Adinarayana returned back and informed that he met Revenue Inspector who said that he is revising the property tax on the building by increasing 100%, and demanded bribe of Rs.70,000/-, for enhancing 25% of the tax and introduced one Mr. Mahesh and asked him to pay the bribe amount to Mr. Mahesh. On 12.6.2019 I again sent Mr. Adinarayana to GVMC office to ask why they are revising the tax of this building when no other buildings are reassessed in GVMC. Accordingly he met Mr. Hari Gopal at his office situated at Zone-III, G.V.M.C., Visakhapatnam and asked him the reason for enhancement of property tax of this building. On that Hari Gopal gave some instructions to Mr. Mahesh and informed Adinarayana to meet Mahesh and discuss with him about this matter. When Adinarayana met Mr. Mahesh at the Office of the Zone-III, he demanded bribe of Rs.1,80,000/- for not increasing the property tax to the above three assessments. When Adinarayana asked Mahesh why should we pay Rs.1,80,000/- as bribe, Mahesh informed him that once they take measurements and fix the tax, there would not be any increase of the property tax for next five years and if they do not increase the property tax for three assessments the assesee will be benefitted around Rs.,12,00,000/- in next five years, but they are asking only 15% on Rs.12,00,000/-. Mr. Adinarayana told Mr. Mahesh that he would inform the same to me and come back. On 15-06-2019, I again sent Mr. Adinarayana to Mr. Hari Gopal, Revenue Inspector to inform about the demand of Rs.1,80,000/- made by Mahesh. On that Hari Gopal informed Adinarayana that he informed Mahesh and asked him to meet Mr. Mahesh on 17-06-2019 as he is not available on that day. On 17-06-2019 at about

11.50 am Mr. Adinarayana met Mr. Mahesh at Circuit House. Mr. Mahesh contacted Mr. Hari Gopal over phone and then he reduced the bribe amount to Rs.1,40,000/-. Mr. Adinarayana informed Mr. Mahesh that he would pass on the matter to me and get back to him. Since then Mr. Mahesh was making calls from his mobile No.8520862647 to Mr. Adinarayana mobile No.9550818002 threatening to increase the property tax if we do not pay the demanded bribe of Rs.1,40,000/- immediately. Today at about 1.30 pm Mr. Mahesh, who is working as Tax Collector, came to my house and demanded to pay the bribe of Rs.1,40,000/- by 20.6.2019, otherwise they will increase the property tax. Though I am not willing to pay the bribe amount I requested him to reduce the bribe amount. Finally he reduced the bribe amount to Rs.1,00,000/- and asked me to pay the bribe amount on 20.6.2019 evening at their office or at my office. I got recorded the conversation with Sri Hari Gopal, Revenue Inspector on 15-06-2019, conversation with Sri Mahesh on 17-06-2019 and my conversation on 19-06-2019 and got transferred into memory cards. I will hand over the memory cards later if necessary.

As I am not interested to pay the bribe amount I request to take necessary action against the Revenue Inspector Mr. Hari Gopal and Sri Mahesh, Tax Collector, Zone III, G.V.M.C., Visakhapatnam.
